# **DISTRICT FIRE OFFICIAL (Robert DeBold)**

- 1. We gave a fire extinguisher class here on Oct. 10<sup>th</sup> to Matawan and Aberdeen Cert members.
- 2. We received estimates for the stucco repairs and roof.
- 3. We met with Dennis Devino the architect and are waiting for him to get back to us with an estimate.
- 4. Truck 497 needed repairs and Pierce came and finish up truck 496.
- 5. Truck 496 was damaged and is out of service.
- 6. The Exterminator came for our yearly inspection and treatment.
- 7. Health Department came for our yearly inspection. We passed and we posted the certificate.
- 8. Bench Tests were performed on 20 paks. All were ok.
- 9. We gave a class to the Home Away from Home teachers on how to properly use the fire extinguishers. 50 Teachers passed and were certified.
- 10. Elections were held here on Nov. 6th. No issues were reported.
- 11.1 sent a letter to the Department of Planning, Zoning and Development for 248 Lloyd Road, at this time the District has no objections. The work that will be done will not affect the District.

12.I sent a second letter to the Department of Planning, Zoning and Development for RPM Development project rejecting the proposal to build higher than permitted by law.
