#### **INSURANCE (Gary Bellone)**

- 1. We received a letter from AMTrust North America our workers compensation insurance in regards to Managed Care Organization they have partnered with Horizon Casualty Services effective September 1, 2018.
- 2. We received a certificate of liability for taking the truck to Wildwood from Pierce Mfg. so the truck is covered while they have it.

#### **BUILDINGS AND GROUNDS: (James Lauro)**

- 1. We contacted contractors to get estimates for a new roof for the truck room, and repair roof by the outside kitchen wall.
- 2. We are also contacting masonry contractors to repair the cracks and broken walls outside.

# **JOINT DISTRICT FIRE TRAINING GROUNDS (James Lauro)**

- 1. The balance in the checking account as of August 31st, 2018 is \$18,837.35
- 2. We receive from Cliffwood and Aberdeen a Certificate of Liability to cover the firefighters at the Training Grounds.
- 3. I spoke with Michael Bellamy about the work being done on the gate. He says he is still waiting to hear whey they are going to start. Don McNab said that they have started to mark out where the fence will go. It should be done by Friday. The Mark out is good for 60 days.
- 4. If any one sees anything that might need repairing or anything else, please let me know and I will take care of it.

A Motion was made by Paul Percussi to accept the Building and Grounds and Joint Districts Reports, second by Gary Bellone. All in favor.

### **DISTRICT FIRE OFFICIAL (Robert DeBold)**

- 495, 496, 498 and 500 went out for their annual service. They will start other repairs. Gary Bellone asked about other repairs. Truck 500 needs a lift motor for the cab it will be done here. Truck 498 is a lift but also a valve replacement and something else. We wanted to get it back here so we can get the rescue truck done.
- 2. We contacted the schools for October Fire Prevention Month. We sent letters confirming the dates we were going there. This year Family Promise will be coming to the fire house for fire prevention. The schedule is posted in the radio room.
- 3. The plumber came to repair the a/c on the second floor. He added Freon. It's working now. We won't know till April if Freon worked.
- 4. I would like to thank Chief Mocci and especially Don McNab for all of the work they did on the new fire truck mounting the brackets and all the time you put in doing it. He helped the district out immensely.
- 5. Today Safety Management Resources guy came to set up Loss Control Visit for Workers Comp. He walked around checking hazards and taking pictures making sure everything was safe. There were no issues that we can see.
- 6. Sept. 12<sup>th</sup>, Pierce is coming to pick up 497 to bring it to Wildwood Convention. They gave us an insurance certificate, they are liable for the entire time they have the truck.
- 7. Pierce Manufacturing presented us with a framed picture of the new truck 497 along with hats for all the firemen. I distributed the hats to the firemen and will get the picture mounted.
- 8. I met with the roofer today about getting and estimate for roof replaced/repaired. We will continue to get more to see if we need to go out and get bids.
- 9. We received an EZpass tag for car 502. All vehicles have ezpass tags and they are old so we might have to have them replaced. We will keep an eye on that.
